GSR Report (Jasen H.)

- The District has a surplus from 2020 of approximately \$3,000 and will present suggestions to be voted on as to how to use the surplus. If anyone has suggestions, bring to Jasen and he will take them to the District meeting.

- Current balance = \$4196.12
- Expenses for the group should be pretty well stabilized and Susan expects to hit our goal of a \$4,200 prudent reserve by the March business meeting.

Email and Group Member List

- Email list – need to discuss if and how the group wants to use a contact list.
 - Email, phone numbers, sobriety date, etc.
 - Whether to publish or not, and where.

Discussion:

- Preference for phone numbers only; a lot of people have their last names in their email address so it's not very anonymous.
- We could put hard copies in the notebook and people would have to go get it. That would also require people to be at the meeting.
- Jasen posting on the District website, other groups do that as well.
- If we have the email address listed and if someone wants to email, they would be able to find it if it's on the District website.
- Give people the choice of what information they want to include in the list.

February 20, 2021

- With a phone number, people could text me rather than email.
- We could have a slot for all information, and you could choose what you want to fill in.

Decisions:

- Also have to vote on the group to pay for it.
- Jasen pointed out that we have not yet given money to GSO or to Intergroup yet; we have been working to get the prudent reserve.
