# **Reports:**

#### **GSR Report** (Jasen H.)

- The District created a Spanish interpreter position in 2014. They have not been able to fill this position for some time. That makes the Area Chair responsible for translation.
  - A motion was made to remove this service position for the Winter Conference. All but 1 group agreed.
  - o Now the Spanish interpreter position is open to anyone to do as a service position.
- Jasen is the new District Treasurer. The District bank balance does not match the numbers given. Jasen is hoping to figure out the discrepancy by the next meeting. He thinks it was an incorrect number written down that was carried through.

#### **Treasurer Report** (Tim reporting for Susan D.)
