**Re:** Area 51 Winter 2025 Committee Highlights

The Area 51 Summer Committee was held on March 8-9, 2025, at the Village Inn Clemmons, NC. There were 71 total members in attendance of which 47 were voting members, making our quorum 32. The theme for the 2025 Spring Assembly will be “**Longevity, Strength, Love**”. The Committee is sending 3 items to the Spring Assembly for approval (background material included with the Spring Assembly Notice):

- That Area 51 annually purchases the AirTable subscription.
- Area 51 to procure a general liability insurance policy for the NC General Service Committee Inc. to include errors and omissions liabilities and special events coverage.
- To approve that the 2026 Area 51 Corrections Conference, “37th Freedom from Bondage,” be held at the Hampton Inn & Suites in Aberdeen, N.C. on March 20-22, 2026.

Treasurer: Contribute by check or via the 'contribute' button at <https://aanorthcarolina.org/contribute>. Our 2025 budget of \$130,454—a 22% increase from 2021—may lead to funding shortfalls after 2026 unless contributions increase, or costs are reduced.

Registrar: Working on ensuring the data between Area and Fellowship Connection is consistent. Asking DCMs to reach out to every group and ensure they are registered in Fellowship Connection so that trusted leaders feel acknowledged, and all members feel heard and valued!

Accessibilities: Scott and the accessibilities committee are focusing on the Third Tradition, and their mission is to identify and remove obstacles to full membership in AA and to ensure that all members can participate fully, including attending meetings and accessing AA literature and events.

Treatment: Website is live to collect volunteer information for treatment facilities - NC TFC VOLUNTEERS – <https://www.nctfc.org>

Website: Justin is working across subcommittees to make the website more accessible to the visually impaired, leveraging technological advances such as Artificial Intelligence (AI) and language models.

Webmaster: Alan is keeping up with all the requests to maintain information on the website <https://aanorthcarolina.org>

Literature: Paul has been setting up displays at area events – he has the new Service Manual and the Plain Language Big Book available.

CPC: Alana has been attending many events and is currently reaching out to nursing education leaders at Duke and UNC to offer speaking engagements.

PI: George is looking for volunteers to develop a strategy for producing consistent, high-quality content by and for A.A. members for platforms like Instagram and YouTube.

Corrections: Jerry has a lot going on working to reignite the relationships with the State Deputy of Prisons and working to get North Carolina digital literature available on tablets at the jails and prisons. Volunteer database is being updated so please respond if you are contacted.
